The P.T.O. will be purchasing t-shirts and a folder for the elementary students using the new logo. Mr. Stein reported on the waterline repairs at Peotone Elementary. Students were transferred to the Connor Shaw Center and the food service personnel provided lunch for the day. Gary Love and his staff repaired the leak and the students have returned to their

respective school. Mr. Stein reported that the district will need to perform extensive maintenance on the plumbing in all of the elementary schools. President Robinson and Steve Stein will be creating an annual agenda for the board. This documentation will highlight items that will be scheduled for approval during the year. Mr. Stein and the board discussed the future usage of the Wilton Center Elementary building.

Kirt Hendrick, Business Manager, report that the move will be coordinated by Tracy Hiller, Kathy Davis, and the custodians. A week has been lost due to the extension of the school year. The move will occur in seven (7) weeks. Moving pods will be placed at each school to allow the teachers and staff to begin preparing for the move.

Terry Wuske, Director of Food Services, reported that the Food Service Department is preparing to serve a cold bag lunch to the students of the Peotone Intermediate Center beginning with the 2014/2015 school year. Mrs. Wuske presented a sample menu to the board for review. The program will need a point of sale computer, ID system, and point of sale cashier. This person would be responsible for transporting the lunches to the school in the portable units from the high school. The board discussed upgrading the septic system and water at the Peotone Intermediate Center.

Dr. Charles Vitton, Director of Curriculum/Technology, presented an overview of the proposed Technology Plan for the district. Dr Vitton reviewed the timeline for the replacement of the district computers and hardware.
