

BOARD OF EDUCATION-REGULAR BOARD MEETING MINUTES OF MONDAY, SEPTEMBER 20, 2021 PEOTONE HIGH SCHOOL - MEDIA CENTER

CALL TO ORDER:

At 6:00 p.m., President Tara Robinson called the regular board meeting to order and requested all who are present to please stand and recite the Pledge of Allegiance. A roll call was taken and the following board members answered aye (7): Mrs. Tara Robinson, Mr. Roger Bettenhausen, Mrs. Jodi Becker, Mr. Richard Uthe, Mr. Tim Stoub (via telephone), Mrs. Jennifer Moe, and Mrs. Dawn Love.

DISTRICT'S E-LEARNING/REMOTE LEARNING PLAN HEARING:

At 6:01 p.m. President Robinson asked for a motion to open the e-learning/remote learning plan hearing. Mr. Uthe made a motion and Mrs. Moe seconded the motion, and on a voice call vote, the following board members answered aye (7); Mrs. Robinson, Mr. Bettenhausen, Mrs. Becker, Mr. Uthe, Mr. Stoub, Mrs. Moe, and Mrs. Love.

President Robinson introduced Mr. Brandon Owens, Director of Curriculum and Instruction, who reported to the Board that the e-learning/remote learning plan has been on the district's website for a couple of months and has also has been published in the newspaper. Essentially the District will need to have an approved e-learning/remote learning plan in place, just in case we have to cancel school. If we do have to cancel school, we would initiate an e-learning/remote learning day, which would work similar to last school year. Not having an approved plan in place for cancellation of a school day - we would have to add the day to the end of the school year.

At 6:05 p.m. President Robinson asked for a motion to close the elearning/remote learning plan hearing. Mr. Uthe made a motion and Mrs. Love seconded the motion, and on a voice call vote, the following board members answered aye (7); Mrs. Robinson, Mr. Bettenhausen, Mrs. Becker, Mr. Uthe, Mr. Stoub, Mrs. Moe, and Mrs. Love.

CONSENT AGENDA:

President Robinson asked for a motion to approve the Consent Agenda items, A through E of the regular board meeting of September 20, 2021. Mr. Uthe made a motion to approve the *Consent Agenda A through E* and Mr. Bettenhausen seconded the motion to approve, and a roll call vote was taken and the following board members answered aye (7): Mr. Bettenhausen, Mrs. Becker, Mr. Uthe, Mrs. Robinson, Mr. Stoub, Mrs. Moe and Mrs. Love.

Mr. Paul Taueber, Assistant Principal/Athletic Director of Peotone High School, addressed the Board and stated that I am proud and excited to announce and introduce Ron Oloffson as our new head coach for Peotone High School's boys' basketball! Ron comes with a wealth of experience and success at the high school level and looking forward to a great season.

Mr. Ron Oloffson said, I am excited to be a blue devil - and I am looking forward to make a difference with the kids, and it is going to be fun!

OPPORTUNITY FOR VISITORS TO SPEAK:

Debbie Batterman, addressed the Board that she has been with the District for 27 years, driving a bus for 25 years and working in the cafeteria for at least 15 of those years. I am addressing the Board tonight because I am being put on unpaid leave because of my refusal of getting the COVID -19 vaccine or complying with the weekly testing. President Robinson told Debbie that the Board will meet with her in closed executive session after the regular board meeting tonight.

Andrea Arens and Laci Lanclos, of Friends of Music, addressed the Board about their annual event - the Chili Cook-off at Brian's in Monee, on Saturday, October 2, 2021, the doors will open at 10:00 a.m., and the winners announced at 4:00 p.m. Wristbands are \$10.00 for all the chili you can eat! Proceeds will benefit the Fine Arts department. Andrea and Laci invited all to come out for this event! But if you can't make it, donations are always welcome, along with baked goods for the bake sale at the Chili Cook-off. If you are interested in donating for the bake sale, please drop off your homemade goodies or store bought goodies at the high school on October 1st from 3:00 p.m. to 5:00 p.m. Andrea informed the Board that theater is returning - Chelsea McKay is planning a Christmas Story and Cinderella in the spring. Our first concert of the season will be on October 21st at 6:00 p.m. at the high school. The price for admission is \$3.00 - but we are also selling family passes for \$25.00 which allows entry to all concerts for all grade levels. Virginia Hamann and Sue Hoffman, addressed the Board with their concerns of mask wearing while driving the bus, the mandate of weekly testing if you are not vaccinated. They also talked about how the bus drivers are being targeted and discriminated against by the District regarding the COVID 19 mandate. We are not treated fairly.

Judy O'Galla, addressed the Board about losing good employees who refuse to get the COVID 19 vaccine or the weekly testing. And that it is not right to let these bus drivers go if they do not get vaccinated or have the weekly testing. Finally, if you are going to test - then you need to test everyone - and if not, it is not right.

Kathy Lyons, addressed the Board with her concerns of mask wearing and the struggles that her daughter, who is a junior at the high school deals with every day wearing a mask. She asked the board to please reconsider this mask mandate.

Steffanie Jennings, addressed the Board and ask the Board if she could read two letters from bus drivers who could not be here tonight. The first letter was from bus driver, Jolene Fritz, who wrote that she extremely uncomfortable about getting the vaccine and will not get it. Most of my reasons are personal – but the biggest reason is that is not the COVID-19 vaccine has not been thoroughly tested. And I am not refusing to be tested weekly, but I will not take part in the nasal swab test, but I am more than willing to take part in the weekly saliva test. I am also upset that only the unvaccinated are required to be tested. The second letter is from Debra Moreno, bus driver, who wrote - I am fervently against this vaccine - it is not anything that I will be putting into my body by choice or by force! The risks are numerous and the benefits are nil, and those who are fully vaccinated- still can get COVID. This is my formal refusal of getting the COVID vaccine and all boosters. And I will not quit my job, resign from my job or take a leave of absence.

Jillian Rojas, addressed the Board with a question - just wondering if all of the board members are also mandated to be vaccinated along with the staff, to keep your positions and if you are not mandated to do so - will you be sharing your vaccine status with us like you. You are here to defend us. We must stand united to stop this madness of the masking of our children, the requirement of vaccinating our employees. What happen to "my body my choice"?

Mr. Steve Stein, Superintendent, responded to the parents and bus drivers tonight, by saying - I certainly appreciate all the passion that everyone has on this subject, but I think the problem is that people are misconstruing a vaccine mandate for a testing mandate. There is no vaccine mandate. No one is being mandated to have a vaccine. What was clearly stated at the July board meeting was myself and the Board very firmly came down on the side that we believe that masking should be option. We do have the force of the mandate which makes us abide by the rules.


Mr. Stein asked Mr. Adam Dauksas, attorney from the law firm that represents the District, to please explain the rules and regulations from his perspective as an attorney.

Mr. Steve Stein, Superintendent, reported to the Board that I received a couple of FOIAs this month. Mr. Trevor Moore, Business Manager, CSBO, reported to the Board that I would like to ask the Board and community members in attendance for help spreading the word about the new fee policy that the Board passed. He reminded them that starting with the 2022-2023 school year, all outstanding fee balances would need to be paid in order to be eligible to participate in extracurricular activities. It is the business office's hope that giving parents nearly a year to plan for the implementation of this new policy will give everyone sufficient time to get outstanding fees paid. Mr. Moore also noted that the policy makes many more fees eligible for a waiver for those who are eligible and he applauded them for being willing to make as many opportunities available to students regardless of ability to pay. Those eligible students are identified by directly qualifying from another government program or by filling out an application that is reviewed by the appropriate administrator.

Mrs. Amy Loy, Director of Special Services, reported to the Board that the Special Services Dept. is busy administering fall assessments. Special educators are administering the alternative assessment (DLM-MAP) to applicable students. Additionally, the EL interventionists in our district, Jackie Clark and Sandy Voss have done a great job getting trained to administer the ACCESS test this fall, and also getting it administered by the deadline last Friday Sept. 17. The EL Interventionists will soon begin the process of completing the WIDA screener for applicable new students to the district that indicated more than English is spoken in their home. Mrs. Loy shared one final note, is that she will soon begin holding 1st quarter Department meetings at each of the district buildings to support teachers and students and make sure all needs are being met. Mr. Jason Spang, Principal of Peotone High School, reported to the Board that: PHS has exciting new to share about Homecoming 2021. We were able to secure a tent through Kankakee Tent and Awning and move the dance outdoors in the student parking lot on Saturday, October 2nd.
